Reason for FSN	Sterility of the products cannot be guaranteed		
Explanation	During a microbiological resistance check, it was found that the Setpack Jerseys made from raw cotton did not pass the sterility tests. This is most likely due to spores that were not sufficiently killed by the sterilization process. Therefore, sterility cannot be guaranteed.		
Expectable risk / harm	As the Setpack Jersey products are used in the operating theatre, this potential unsterility could lead to wound infections.
