Urgent Field Safety Notice

Dear Customers,

DH Healthcare GmbH, a Dedalus Group company, would like to bring to your attention the following issue reported to the national competent authority:

Title: When opening several panels in patient chart, the display of prescription information is not updated

Internal Reference: MST0098426

Information:

A display issue occurs in patient chart when the physician opens in parallel the details panel for several prescription lines. If the physician selects a prescription line, and then selects another one without closing the previously opened panel, the prescription details are not updated in the details panel of the second prescription.

Illustrated scenario:

In a patient record, a physician opens the prescription screen, adds several prescription lines and signs. Then accesses to patient chart in medication section. The physician selects product A by clicking on its label and opens prescription details panel for product A.

As result, prescription details for product A are displayed instead prescription details of product B, although Product B is displayed in the headline. The result is the same if the physician opens details for another products.

To avoid this display issue until the fix is installed, the physician can close the panel before selecting another line.

Release of correction with ORBIS Medication version 03.21.00.00 in ORBIS version 84.43.00.xx or higher (release planned for third quarter of 2025 for DACHL), and 84.43.00.xx and 85.26.00.xx or higher (release planned for last quarter of 2025 for FR).

Recommended actions to be taken by the customer:

- As a physician or nurse, when you consult the panel displaying the details of a prescription line in patient chart and you wish to consult another one, please close the panel first before opening the next one.
- Install the correction when available.

Please distribute this information to all those who need to be aware of it.

Regardless of the situation described here, we would like to point out that care providers must always ensure that clinically relevant information, including prescription information, is clearly communicated and that they must use verified information (e.g., from medical devices such as monitoring systems), independent from the software being used.

It is important that you take the actions described in this safety information and acknowledge receipt of this letter.
