URGENT: FIELD SAFETY NOTICE

Synapse PACS 7.4.x

Dear Customer:

We would like to inform you that FUJIFILM Healthcare Americas Corporation (FUJIFILM) is conducting a voluntary correction for Synapse PACS v7.4.x at customers using the Synapse PACS 7.4.x with Viewer Extension (VX) client.

PROBLEM DESCRIPTIONS

Fujifilm became aware that a patient's age for patients younger than 18 years of age can show incorrectly in the Synapse PACS **V**iewer E**X**tension (**VX**) Client - Image Viewer. For instance, under these circumstances an infant patient's actual age of 26 days may appear incorrectly as 5 days in Synapse VX. However, in such event, the patient's age appears correctly in Synapse PACS Zero Viewer/Thin Viewer and Series Viewer within VX.

In the event a patient's age is relevant to a diagnosis or treatment decisions and an incorrect age is displayed in Synapse VX, the diagnosis or treatment plan could be incorrect.

ACTIONS BY FUJIFILM

Fujifilm will issue corrections for all impacted 7.4.x versions. The following patch releases will be made available:

7.4.020 for 7.4.0x versions

7.4.120 for 7.4.1x versions

7.4.210 for 7.4.2x versions

ACTIONS REQUIRED BY CUSTOMERS

To prevent any issue, Synapse PACS VX can safely be used by the end-user as long as; 1] the end-user is aware of the issue and, 2] takes appropriate actions when rendering a diagnosis for patients under 18 years of age. The following precautions needs to be taken;

1) The image acquisition date and date of birth are displayed on the Image. The end-user can use the dates to verify the age or,

2) Open the Series Viewer by double clicking on the thumbnail displayed on top the Synapse VX Image viewing window or the worklist. The Series Viewer Window will render the image on the server using the Server-side rendering (Zero Viewer component) which will calculate the age correctly. Alternatively, the user can switch to the Synapse PACS Zero Viewer/Thin Viewer (Server-side Rendering). The Synapse PACS Zero Viewer/Thin Viewer calculates the age correctly.
