no. 672 of 23 April 2020

on approval of the list of medical devices required in order to ensure the prevention and treatment of conditions associated with the SARS-CoV-2 infection, whose distribution is temporarily suspended, and of measures required to ensure medicinal products at high risk of discontinuation on the national market

On seeing Approval Report no. NT 1437/23.04.2020 of the Directorate for the policy of medicines and medical devices,

taking into account:

- Decree no. 195/2020 on establishment of the state of emergency on the Romanian territory and Decree no. 240/2020 on extension of the state of emergency on the Romanian territory;
- Article 5 (1) of Military Ordinance no. 1/2020 on certain first emergency measures concerning crowds and cross-border shipping of goods, with subsequent completions;
- Article 804 (21) and (3) of Law 95/2006 on healthcare reform, republished, as further amended;
- Article 4 (3) point 1 and (4) point 4 of Law no. 134/2019 on reorganisation of the National Agency for Medicines and Medical Devices and amendment of further ruling provisions;

pursuant to Article 7 (4) of Government Decision no. 144/2010 on the organisation and operation of the Ministry of Health, as further amended and supplemented,

the minister of health hereby issues the following order:

- **Article 1 -** (1) The list of medical devices required in order to ensure the prevention and treatment of conditions associated with the SARS-CoV-2 infection, whose distribution is temporarily suspended, provided in the Annex which is integral part of this Order, for a 6-month period from the date of entry into force of this Order.
- (2) By waiver from provisions of paragraph (1), deliveries outside Romania of medical devices manufactured in Romania to commercial partners residing outside Romania with whom the Romanian economic operator has concluded a manufacturing or lohn contract, medical devices in transit, as well as deliveries under contract in a joint public procurement launched at European Union level.
- (3) In the situation provided in paragraph (2), the economic operator shall present to the customs office the following:
- a) a copy of the license / certificate / authorisation for operation for the commercial partner based outside Romania, translated into an international language;
- b) a statutory declaration according to which the delivered medical devices are not destined for the Romanian market and whose final destination is the country mentioned in the delivery documents;
- c) the contract (copy) according to which the medical devices are delivered within a common public procurement launched at the level of the European Union.
- (4) For delivery outside Romania of the medical devices provided under paragraph (2), in line with the provisions of Annex I to Commission Implementing Regulation (EU) 2020/402 of 14 March 2020 making the exportation of certain products subject to the production of an export authorisation, the authorisation shall be granted by the national authority responsible for implementation of the European Union's trade policy.
- (5) The shipping of assemblies and subassemblies of medical devices, manufactured in Romania for external beneficiaries, is not subject to the interdiction provided under paragraph (1).
- **Article 2 -** (1) The distribution, for a 6-month period, from the date of entry into force of this Order, of medicinal products included in the Protocol for the treatment of the SARS-Cov-2 virus infection, approved by Order of the Ministry of Health no. 487/2020, with subsequent amendments, as well as medicinal products with an increased risk of discontinuation for chronic pathologies in the

context of the SARS-Cov-2 virus pandemic, provided in the Annex which is part of this Order.

- (2) By waiver from the provisions of paragraph (1), the medicinal products provided in the Annex to this Order may be sent via intra-community delivery outside the territory of Romania under the following conditions:
- a) the economic operator notifies the National Agency for Medicines and Medical Devices of Romania (NAMMDR) the intention to deliver outside Romania 7 working days before delivery, according to the Annex to Order of the Minister of Health no. 269/2017 on mandatory provision of medicinal product adequate and continuous stocks;
- b) The NAMMD analyses the request of the economic operator and may approve or reject its request in case of a discontinuation or risk of discontinuation on the national market. The NAMMDR considers the discontinuations communicated in the last two months by distributors, pharmacies or healthcare professionals. The NAMMDR also considers the situations in which the current stock does not cover the needs of patients in Romania;
- c) the economic operator may also make the delivery if the NAMMDR does not comply with the request within a maximum of 7 working days from the receipt of its notification;
- d) in case the economic operator's request is rejected, the NAMMDR communicates to him the reasons for the decision to reject the respective request;
- e) the economic operator may contest within a maximum of two working days at the NAMMDR the decision of rejection in case it considers that the decision is unfounded, presenting in this respect the necessary arguments; the NAMMDR analyses the appeal of the economic operator and issues the final decision within a maximum of 5 working after receipt of the appeal.
- (3) Medicinal products manufactured by manufacturers based in Romania, including those manufactured under contract, as well as medicinal products that transit the territory of Romania and which are destined for other markets outside Romania are exempted from the provisions of paragraphs (1) and (2).
- (4) In the case of the medicinal products provided in paragraph (3), the manufacturer shall present to the customs office:
- a) a copy of the manufacturing authorisation accompanied by Annex 8, approved by the NAMMDR, specifying the respective medicinal products. If the medicinal products are not provided in Annex 8, the manufacturer must provide a copy of the marketing authorisation / special needs import authorisation / import

permit, translated into an international language, approved by the competent authority of the country of destination;

- b) a statutory declaration, according to which the delivered medicinal products are not destined for the Romanian market and whose final destination is the country mentioned in the delivery documents.
- (5) The medicinal products mentioned under paragraph (3) can only be exported if the NAMMDR approved the export declarations in line with Order of the Minister of Public Health no. 894/2006 on approval of Regulations regarding export of medicinal products for human use, as further amended, and with Order of the Minister of Public Health no. 1809/2006 on approval of Norms concerning the approval of export declaration for medicinal products for human use in compliance with the provisions of this Order.
- **Article 3 -** For the purpose of this order, the terms below have the following meaning:
 - a) export any delivery to third countries,
- b) *delivery outside the Romanian territory* intra-community delivery and/or delivery to third countries;
 - c) distribution delivery or export outside the Romanian territory.
- **Article 4 -** Noncompliance with the provisions of this Order shall be sanctioned according to the provisions of Article 875 (1) k) of Law 95/2006 on the healthcare reform, republished, as further amended and supplemented.
- **Article 5 -** On this Order coming into force, Order of the Minister of Health no. 428/2020 on approval of the List of medical devices and healthcare materials to ensure prevention and treatment of diseases associated with the SARS-VOC-2 infection, whose distribution outside Romania is temporarily suspended, as well as of the measures to ensure medicines included in the CANAMED National Catalogue of the Prices of Medicinal Products Authorised for Marketing in Romania, published in the Official Gazette of Romania, Part I, no. 202 of March 12, 2020, as further amended and supplemented.
 - **Article 6 -** This Order shall be published in the Official Journal of Romania, Part I.
